


It's hard to believe that this could possibly be UFO Central? My name is Wilbur Allen; I am the son and product of the United States Air Force. Born to the US Military, on a military base now closed (Westover AFB). I was raised and educated on military bases during the Vietnam War. My father was an expert in his field of: PMEL, a supportive element of Military Intelligence. He taught me the elements of advanced photography, which I applied to this extraordinary forensic sample of UFO Close Encounters of the Third Kind at the US Capitol in Washington DC.

I will show forensic proof of anomalous activity by airborne anomalies (UFO's), which demonstrated maneuverability unlike anything conventional known, to man. I will show proof of alien technology that I can only describe as a Stargate. That an airborne anomaly oscillated triaxially, (x, y, z), generating a repeating pattern in multiple directions, prior to altering its physical state of solid to plasma? I shall connect the dots starting in 1942, to this point in time which I shall register as 09-12-2009. However I start in July of 1952\*

I will let the physical samples do most of the talking. ..However; I am a professional photographer and inventor. I started taking pictures in 6th grade, processing and printing B&W and color film (E-6). In highschool I invented a linear film development technology, which allowed me to exceed the physical (manufactures) limits of the films used in imaging at that time. I am an expert in the manipulation of the physical structure of the film, to get images where no other has been able? My first camera was a Nikon F-2, my fathers camera a Nikon F, the standard in Vietnam.







#### F-16s Pursue Unknown Craft Over Region

For Renny Rogers, it was strange enough that military jets were flying low over his home in Waldorf in the middle of the night. It was what he thinks he saw when he headed outside to look early yesterday that floored him.

"It was this object, this light-blue object, traveling at a phenomenal rate of speed," Rogers said. "This Air Force jet was right behind it, chasing it, but the object was just leaving him in the dust. I told my neighbor, 'I think those jets are chasing a UFO."

Military officials confirm that two F-16 jets from Andrews Air Force Base were scrambled early yesterday after radar detected an unknown aircraft in area airspace. But they scoff at the idea that the jets were chasing a strange and speedy, blue unidentified flying object.

"We had a track of interest, so we sent up some aircraft," said Maj. Douglas Martin, a spokesman for the North American Aerospace Defense Command in Colorado, which has responsibility for defending U.S. airspace. "Everything was fine in the sky, so they returned home."

At the same time, military officials say they do not know just what the jets were chasing, because whatever it was disappeared. "There are any number of scenarios, but we don't know what it was," said Maj. Barry Venable, another spokesman for NORAD.

Radar detected a low, slow-flying aircraft about 1 a.m. yesterday, according to a military official. Controllers were unable to establish radio communication with the unidentified aircraft, and NORAD was notified. When the F-16s carrying air-to-air missiles were launched from Andrews, the unidentified aircraft's track faded from the radar, the military official said, speaking on condition of anonymity.

Pilots with the D.C. Air National Guard's 113th Air Wing, which flew the F-16s from Andrews, reported nothing out of the ordinary, NORAD officials said.


"It was a routine launch," said L. Col. Steve Chase, a senior officer with the wing, which keeps pilots and armed jets on 24-hour alert at Andrews to respond to incidents as part of an air defense system protecting Washington after the Sept. 11 terrorist attacks.

Rogers remains convinced that what he saw was not routine. "It looked like a shooting star with no trailing mist," he said. "I've never seen anything like it."


Apollo 16 Moon Mission and the reflection of Commander Buzz Aldrin's visor with Blue/green anomaly.







It is safe to conclude that these blue anomalies first encountered on the Moon in 1972, where originally based there, however; are from another region of space.\*













UFO Flight/Landing trajectory and energy buildup too Stargate escapement.







I stopped visiting the Capitol after my July 2002 Close Encounter @ the Capitol Building, however; until my birthday on October 22, 2008\*. I was sort of unnerved by my 2002 experience and had developed a phobia (Post Traumatic Stress) from what I could not remember of that night, which 15 minutes is a blank? This\* night I got the Birthday present that beat them all: HD 1080 I UFO samples of micro/macro UFO anomalies in the ground and air of the US Capitol, and what I thought to be a cloaked reptile (plesiosaurs). 


Lunar surface with Dome anomaly.



Three family members saw a green fireball, about the size of a tennis ball,

travel E to W for 3 seconds, with trailing red-orange spark

Three members of our family were sitting on our deck, enjoying the cool breeze, and were trying to see the ISS, which was supposed to come over. We didn't see the ISS, but my wife saw a green fireball, which was trailing red-orange sparks, and a long white tail, with green and red mixed in. She said "Look". My son and granddaughter looked up in time to see the object. It was traveling from east to west. It appeared about 60-70 degrees above the southern horizon. It lasted about 3 seconds. What was interesting, was that it was long enough, for my son and granddaughter to react, and observe it.

Unfortunately, I had gone inside to check on the internet , regarding the time of the ISS passage, and missed it . It was the first time the three had ever seen a fireball. The object looked like the size of a tennis ball, held at arms length, and the tail was as wide as the fireball was thick. The object eventually disappeared over our roof, as our deck is on the east side of our house. Therefore, we don't know if it continued to be visible. However, my wife is sure it was visible for about 3 seconds, at least. What was strange, though, is that it seemed to travel parallel to the ground, not descending, as one would expect, if it were entering the atmosphere.


Orange Disc anomaly imaged in HD over trees in Baltimore Maryland






July 2002 was an exceptional year in UFO History. It was the first time a full color sample, with forensic detail of a UFO has ever been photographed? What makes this sample extraordinary is the fact that I captured several different levels of Technology in the air? One in particular was most exceptionall The J4 Pulse anomaly which suddenly appears in the initial image as if it opened a door and suddenly appeared? Oddly on the film sample it looks as if it just manifested into reality from nowhere? The object pulsed through the air and then stops suddenly, 100% stationary? It maintained sufficient stillness to capture an exceptional image showing a dazzling Blue and Yellow/Green UFO anomaly; however 1 frame showed the design of an alien spacecraft and its propulsion system shockwave.

The frames of images are without doubt, for the time, technologically superior image files showing anomalous airborne activity in Restricted Air Space P-51, Washington DC proper. (Areas around the Capitol and Monuments are off limits to conventional and military flight (to a degree). However, my samples reflect a level of technology which did not exist at the time, by fact I invented my film and processing technology. The level of research I obtained in film development exceeded all the manufactures film specifications. I have created a technology which augmented the image at the molecular level, over a gradual, but substantially extended period of development time. Understanding inverse proportions and geometric progressions of a controlled chemical reaction, I was able to control granular distortion and eliminate reciprocity failure, while generating files with superior image data.

This at that time, was unheard of? However, what I captured was multiple frames of events, captured from a fixed platform (camera was focused and set to one specific location. The F-5's automation programmed for enhanced exposure, allowed for illuminated samples to appear that are beyond the range of human vision.


Though this is the 3rd volume in my series of UFO Forensic Files, it is actually my first recorded UFO encounter. ### F-16s Pursue Unknown Craft Over Region

For Renny Rogers, it was strange enough that military jets were flying low over his home in Waldorf in the middle of the night. It was what he thinks he saw when he headed outside to look early yesterday that floored him.

"It was this object, this light-blue object, traveling at a phenomenal rate of speed," Rogers said. "This Air Force jet was right behind it, chasing it, but the object was just leaving him in the dust. I told my neighbor, 'I think those jets are chasing a UFO.'"

Military officials confirm that two F-16 jets from Andrews Air Force Base were scrambled early yesterday after radar detected an unknown aircraft in area airspace. But they scoff at the idea that the jets were chasing a strange and speedy, blue unidentified flying object.

"We had a track of interest, so we sent up some aircraft," said Maj. Douglas Martin, a spokesman for the North American Aerospace Defense Command in Colorado, which has responsibility for defending U.S. airspace. "Everything was fine in the sky, so they returned home."

At the same time, military officials say they do not know just what the jets were chasing, because whatever it was disappeared. "There are any number of scenarios, but we don't know what it was," said Maj. Barry Venable, another spokesman for NORAD.


Radar detected a low, slow-flying aircraft about 1 a.m. yesterday, according to a military official. Controllers were unable to establish radio communication with the unidentified aircraft, and NORAD was notified. When the F-16s carrying air-to-air missiles were launched from Andrews, the unidentified aircraft's track faded from the radar, the military official said, speaking on condition of anonymity.


Pilots with the D.C. Air National Guard's 113th Air Wing, which flew the F-16s from Andrews, reported nothing out of the ordinary, NORAD officials said.

"It was a routine launch," said Lt. Col. Steve Chase, a senior officer with the wing, which keeps pilots and armed jets on 24-hour alert at Andrews to respond to incidents as part of an air defense system protecting Washington after the Sept. 11 terrorist attacks.

Rogers remains convinced that what he saw was not routine. "It looked like a shooting star with no trailing mist," he said. "I've never seen anything like it."



# 17 Ducks Found Dead in Capitol Reflecting Pool Sunday, July 13, 2008

Authorities searched near the Capitol into the early hours of yesterday morning for possible hazardous materials after more than a dozen ducks were found dead in the Capitol Reflecting Pool.

D.C. police and fire department personnel and federal officers tested for chemical, biological and radiological agents after 17 dead ducks were spotted in the pool, D.C. Assistant Police Chief Patrick Burke said. The tests were precautionary because of the proximity to the Capitol, Burke said.

There was no indication of what caused the deaths. The pool is at the east end of the Mall, at the edge of the Capitol lawn.

"It's a mystery," D.C. Fire and Emergency Services Department spokesman Alan Etter said. He noted that whatever caused the deaths might have been encountered "at another location."

Etter said authorities remained at the scene until about 4:30 a.m. yesterday.

Burke said that the ducks have been sent for testing and that authorities are awaiting the results.

I graphed the motion photo by photo. The stationary star was indeed stationary. Therefore all motion of the moving light was due to its own motion.

The attached graph shows that most of the movement was in the horizontal direction to the right, with some motion downward. The graph of the horizontal motion is nearly a perfect straight line.

Errors in measurement of the position could account for slight non-linearity (where data points don't lie exactly on a straight line.

The point is that the moving light was moving at a constant velocity starting at the first photo and ending during the last photo.

--------

You have suggested that if the light moved downward suddenly making the "trail" that the trail would be the same width as the object/light...that is, the width of the trail would equal the width of the "dot" image which I claim is overexposed. My analysis suggests that the "dot" image is larger than it should be, that is, the brightness has increased the size of the image. In this case, width of the trial would be closer to the actual width of the image if underexposed, (I have experimented with the effect of brightness on image size using light sources of certain sizes that can be adjusted to various brightness levels. Invariably the size at "good" exposure is the "geometric size" that is given by  $S = (O/D) \times F$  where S if the size (width) of the image, O is the size of the object/light (as measured perpendicular to the line of sight/lens axis), D is the distance from the camera to the object/light and F is the focal length.) As the brightness increases the

image size grows larger than the geometric size. Thus a "point source" light like a distant star makes an image size that depends upon the brightness of the star. The fact that image size is related to star brightness was used by astronomers to measure the relative brightness's

Regarding the moving light of July 20:

At a distance of 5000 ft (about a mile) this corresponds to 5000 x ,0326 rad/sec = 163 ft/sec or about 2 mph during the slow travel (the initial ten frames)

IF THE STREAK IS A RESULT OF SUDDEN MOTION OF THE LIGHT then, IF it were 5000 ft away, AND IF the streak were created in .02 sec as suggested above, then It moved at a rate 1.6 rad/sec x 5000 = 9000 ft/sec = 102 mph during the last 1/10 of a frame time (.2/10 = .02 sec).

Could this be true, that it accelerated from 2 mph to about 100 mph in .02 sec? or some such fraction of a second?

The problem is we have to make 3 guesses: a) is the "trail" a result of the light moving, b) what is the time duration of the trail, and c) what was the distance? If the trail was not the result of the light moving then what caused it? Can we rule out a vibration of the camera during the last photo?

The bright "dot" from which the trail emanates seems to be the same size as the bright dot in the preceding photo. This implies little change in the exposure time of the light dot image. This in turn sets a "upper bound" on the amount of time during the trail. In other words, for example. the light did not start moving halfway through the exposure time or at any time before halfway because if it did the size (which grows with exposure) would be smaller than the previous image.






